A proposed settlement has been reached in a class action lawsuit *Amin v. Mercedes-Benz USA*, 17-cv-01701, (N.D. WHO IS INCLUDED: All current and former owners and lessees of any Mercedes vehicles listed on the other side of this postcard, who purchased or leased their vehicles in the United States.

SETTLEMENT BENEFITS: The Settlement provides two types of benefits: <u>reimbursement</u> for past repairs of the HVAC system and <u>coverage</u> for future HVAC repairs. The amount of reimbursement and coverage depends on how many miles or years have passed since the vehicle's original in-service date at the time of the repair. Coverage is up to 10 years or 125,000 miles, whichever comes first. Certain restrictions apply. For details, visit **www.mercedeshvacsettlement.com**.

HOW TO FILE A CLAIM: To get reimbursed for past HVAC repairs, you must submit a claim online or by mail. Visit **www.mercedeshvacsettlement.com** to download a claim form or submit a claim online. You may also call toll-free 844-924-0851 to have a claim form mailed to you. For repairs done before May 11, 2020, your claim must be submitted by July 25, 2020. For repairs done between May 11, 2020 and December 7, 2020, your claim must be submitted within 75 days of the repair.

You do not have to file a claim to seek coverage for future HVAC repairs.

YOUR OPTIONS: You can file a claim, exclude yourself ("opt out"), object to the Settlement, or do nothing. The deadline to opt out or object is July 25, 2020. If you do not opt out, and the Court approves the Settlement, you will release your claims against Defendants. The Court will hold a hearing on September 9, 2020 to decide whether to approve the Settlement. You may attend.
